Review December 2022 Financials:

- Deb read the December Financials
 - We have \$166,005 in Plains Checking
 - Plains Money Market is \$80,942
 - Accrued interest on CD's is \$4,932
 - December Funds from City of \$20,162 Will be received in January 2023
 - Note a decrease of \$1,942 from prior year
 - The decrease is related to one delinquent property on the December 2022 BID Tax report
 - \$65 due to the CVB
 - \$65-Marketing funds
 - Retained earnings \$406,061
 - Total \$403,947.71
 - o Julie made a motion to approve the financial report, Connie 2nd, all approved.

New Business

- Bob Linneman with Dakota Gold Academy asking for \$2500.00
 - Lynn asked about how many rooms there will be
 - He really didn't know
 - Deb said they have the judges and then some
 - Bob said there are going to be 462 kids registered
 - 58 Watertown, 32 Clear Lake, some from up by Detroit Lakes They came last year and had a blast
 - Bob said the judges will be coming from Michigan, Omaha, Wyoming, & Spearfish
 - They pay for all their expenses
 - Connie asked if he puts up bleachers?
 - Bob said they use risers with chairs, about 100 seats
