# **Review February 2023 Minutes:**

• Deb made a motion to approve the February minutes, Julie seconded, All approved

# **Review February 2022 Financials:**

- Deb read the February Financials
  - We have \$185,268 in Plains Checking
  - Plains Money Market is \$80,956
  - Accrued interest on CD's is \$5,378
  - February Funds from City of \$15,428 Will be received in March 2023
  - Retained earnings \$420,565
  - Total expense of \$59,794 through Feb 28, 2023
  - Net Loss of \$25,705 through Feb 28, 2023
- Angle is recommending that we move some money because we are close to the insurance limit
  - Anjelica read Angie's recommendation
    - Connie said maybe we open a CD
    - Lynn made a motion that we check on other rates for \$50,000, Julie 2nd all approved
  - Julie made a motion to approve the financial report, Connie 2nd, all approved.

## **New Business**

- Carla O'Farrell Studio 212 Dart Tournament, Tom was on the phone
  - Lynn asked how many out-of-towners did you have at the last one?
    - Carla said over 1000 people attended
    - Carla said Alvin in Aberdeen and they have 16 teams right now but there is always those that wait for the last minute
    - Tom asked how the hotels did last time?
      - Connie said they had a lot of Milbank people
      - The BID suggested that they do a password of some sort
      - Tom said he could go around and ask where they all were staying, there will be teams from MN, & IA

- Carla asked if people were coming and staying for the concerts?
  - Deb & Lynn said not really
- Lynn asked if they knew how many people will be staying in town
- The tournament will start Friday AM
- Connie suggested you could do a coupon per room for a \$1 off the concession & put Beverage and expiration date on it
  - Tom said he would get some coupons made up
    - Get hotels & rooms to Carla
- Lynn explained how the BID works with the \$10/per night/per room
- Deb explained how the blocks worked
- Lynn thanked Tom & Carla and how appreciated we were that they came in
- Lynn said it is a great Venue they are doing great things
  - Angelica said the pay-outs were \$1500 & \$2000
  - Lynn doesn't think they will get 150 rooms
  - o Julie thinks no more than 1500.00 We will pay them for the coupon
  - Julie made a motion to give Studio 212 1500.00 based on 150 rooms, Deb 2nd all approved

## **Old Business:**

- NSAA Room Nights
  - Anjelica commented about Roger's letter which was sent out with the BID Documents
    - Roger wants more money
    - Roger said we were supposed to give them \$5000 per Men's & \$5000 per Women's team.
      - Anjelica found a letter where he tried to do that last year with Kat
      - Lynn doesn't respect dishonesty
      - Connie said we didn't promise him he would make \$3700
    - Students said we didn't advertise enough to get people at the tournament
    - Anjelica we will need to get sponsorship for Live Streaming & the T-Shirts
  - Deb mentioned that the NSAA traveled to different colleges and they were doing their AD conferences here in Watertown because it is centrally located
  - Comparison 2022 to 2023
  - Lynn said maybe we need to do a longer commitment, maybe 5 yr.
  - Julie said to use the document that says VB-\$5000, BB-\$5000
  - Lynn Longer commitment on their part
  - We pay for officials rooms Anjelica doen't agree with that
  - Deb said we are paying way too much
  - Lynn asked if he's complaining about that we didn't have enough fans there
  - Julie said we need to meet him in the middle \$2000 one direction or the other
  - Lynn said we would not have rooms if they didn't have the tournament
    - Could base the extra money on things that have increased in all areas
  - Roger is not being appreciative of what we do
  - Deb talked about HS tournaments & cost

- Connie asked what have we done for the past HS tournaments
  - Tammy talked about what we had done in the past with the hospitality room and meals
- Anjelica will get our total cost
- Deb said she doesn't think we should commit for 5 years
  - Julie asked why?
  - Lynn said it would be a comfortable commitment of an extra \$2000 for 5 vr.
  - Jeri said we should start high
